

DATA PROCESSING POLICY

Restur S.r.l. with registered office in via della Camilluccia 480 00135 Rome as the data controller (hereinafter referred to as the "Controller"), issues this notice to the Data Subject in compliance with the European and Italian regulations on the protection of personal data.

Purpose and legal basis of processing

If you subscribe to this service, Restur S.r.l. will process the data collected to send e-mail newsletters containing information about its products or services, as well as promotions or invitations to events in which it will participate. The legal basis is the necessity for the pursuit of the above purpose.

Data retention period

The Controller will process your data until the completion of the service or the request to unsubscribe, whichever is earlier. In any case, for technical/organizational reasons, the processing will last for 30 days from the above terms.

Nature of data provision and consequences in case of refusal

The provision of data is optional, but refusal to provide them will result in the inability to register for this service.

Scope of data communication and categories of recipients

Exclusively for the purposes specified above, all data collected and processed may be disclosed by Restur S.r.l. to internal staff authorized to process them due to their respective duties, as well as to the following categories of external parties, as independent controllers or external processors:

- providers of IT services, such as direct marketing, internet service and cloud computing;
- subsidiaries, parents, investees and affiliates;
- public authorities and supervisory and control bodies;
- third-party companies as part of transactions involving the acquisition or sale of the company or a branch thereof.

Such recipients, should they process data on behalf of **Restur S.r.l.**, will be designated as data processors, by a specific contract or other legal act. The updated list of the Recipients of personal data is available upon specific request to the data controller Restur S.r.l. by the means indicated in the paragraph "Rights of Data Subjects" below. No data collected at the Website is subject to dissemination.

Data transfer to a third country and/or international organization

Your personal data may be transferred, for the purposes for which they are collected, to the **United States of America (USA)** which is a country outside the European Union.
